

3.0. Restricted Merchants & High-Risk Merchants

AFS recognizes that business opportunities may be presented by merchant types which pose increased risks through higher chargebacks and refunds due to the nature of the product or service provided (e.g., items that are easily sold on the black market, items that have little or no value which may be easily disputed, etc.). The risk presented by these business opportunities can be closely monitored and controlled, and therefore mitigated, to present an acceptable level of processing risk.

Businesses on the Restricted List (Sections 3.1) should be reviewed with greater scrutiny. When reviewing a business, the merchant should show greater ability to control the risk inherent to its business type.

Section 3.1 is not meant to be all-inclusive. Other types of merchants or products may fall under the restricted category due to the type of business as determined on a case-by-case basis.

- Alcohol or alcoholic beverages sales (Internet/MOTO), including wineries that follow age verification at the time of sale and delivery and business to business (AVIDIA ONLY)
- **Amusement Parks**
- Any merchant using "Pay" or "Payment" in either OBA or Legal Names
- Auction Houses (penny bidding auctions are prohibited)
- **Automated Referral Services**
- Automobile clubs
- Benefit programs
- Books, E-Books, Periodicals, and Newspapers (subscriptions)
- Cable and other pay TV programs
- Cablegrams and Telegrams
- Career Placement or Advice Center Merchants



- Carpet, Rugs, and Floor coverings with future delivery
- Charitable organizations related to Civic, Political, and other Registered Organizations (not including organizations related to religious, disaster recovery, or other unregistered causes)
- Collectible, and Memorabilia stores
 - Faces, Names and Signatures
 - No special orders
 - Computer Hardware Equipment/Supplies (Online only)
 - Computer Maintenance/Repair Services/ Personal Computer Technical Support (Online only)
 - Correspondence Schools
 - Delayed Delivery Merchants where the good or service the merchant is providing the cardholder is not shipped, delivered, or fulfilled when the card transaction is processed but is to occur at a future date
 - Detective Services/Private Investigators
 - Donations/Charities (Political)
 - DVD Converters
 - Electronics including: (Future Delivery or Online)
 - Stereo Sales, Home and Auto
 - Telecommunication Equipment and Telephone Sales beepers, pagers, paging equipment, cell phones
 - Embassy, Foreign Consulate, or Other Foreign Government
 - Employment Agencies
 - Fantasy Sports (Avidia Only)
 - Hair Restoration (non-medical)
 - Hardware Equipment with installation or future delivery
